

### Aid & Attendance

Aid and Attendance is a benefit paid by the Veterans Administration to wartime veterans over 65, their spouses or surviving spouses. Paid in addition to a basic monthly pension, veterans are eligible when they require the aid and attendance of someone else.

When a veteran requires assistance with daily activities like eating, bathing, toileting, dressing or medication assistance, Aid and Attendance can help pay for care in home, in an assisted living community or in a nursing facility.

To be eligible for Aid and Attendance, veterans have to meet the following criteria:

- Be eligible for a VA pension
- Meet income and asset limitations
- Meet disability requirements
- Meet service requirements

To apply for Aid and Attendance, veterans can visit their local regional benefit office to file a request or write the Pension Management Center (PMC) which serves Texas. When applying, a detailed report from a physician certifying the need for care is recommended. The VA provides downloadable forms online to fill out and send to the regional VA office.

The PMC address for Texas as well as a link outlining the criteria for the physician's report is listed on the resource page. In Bexar county, the Bexar County Veterans Service Office (VSO) schedules appointments for benefits counseling and referral services.

To check the status of a claim, veterans can contact the VA Pension Maintenance Center at 877-294-6380.
